

BIG WEDNESDAY TERMS AND CONDITIONS

1. DIVISION 1

- (a) The Division 1 prize includes money and prizes in kind payable as follows.

Motor Vehicles and Boats

- (b) A motor vehicle and boat are payable either in kind or in money at the specified amount by cheque or direct credit.
- (c) To be eligible to claim a motor vehicle or boat in kind a prize winner, or a person nominated by the prize winner to claim the prize, must be 18 years of age or older.
- (d) If a prize winner is under 18 years of age and doesn't nominate a person 18 years of age or older to claim a motor vehicle or boat in kind the prize will be paid in money by cheque or direct credit.

Charge Card

- (e) A charge card is payable either in kind at the specified amount or in money at the specified amount by cheque or direct credit.
- (f) To be eligible to claim a charge card in kind a prize winner must be a New Zealand resident, 18 years of age or older, complete an application form from the issuing bank and satisfy the issuing bank's card criteria. If a prize winner doesn't meet these conditions the prize will be paid the prize in money at the specified amount by cheque or direct credit.
- (h) A supplementary charge card cannot be issued for a charge card claimed in kind.
- (i) A charge card claimed in kind will be suspended by the issuing bank when card expenditure reaches the specified amount. A prize winner must re-apply to the issuing bank to continue to use the card with such use at the issuing bank's discretion. If continued card use is permitted the prize winner will be subject to the annual fees and terms and conditions set by the issuing bank.

Bach

- (h) The cash prize towards a bach is payable at the specified amount by cheque or direct credit.

Travel

- (i) The cash prize towards travel is payable at the specified amount by cheque or direct credit.

Special Prize

- (j) From time to time New Zealand Lotteries Commission ("NZ Lotteries") may at its discretion include as part of the Division 1 prize:
- (i) a special cash prize towards an event, purpose or object determined by NZ Lotteries payable at the specified amount by cheque or direct credit; and/or

- (ii) a special prize in kind determined by NZ Lotteries payable either in kind or in money at the specified amount by cheque or direct credit.
- (k) To be eligible to claim a special prize in kind a prize winner must be 18 years of age or older.

2. DIVISION 2

The Division 2 prize is money payable by cheque or direct credit.

3. JACKPOTS

The Big Wednesday Rules 2005 and NZ Lotteries Big Wednesday Jackpot Policy govern Division 1 prize jackpots and Division 2 prize jackpots including for each division the threshold amount' (\$30 million), 'maximum number of games' (52) and 'must be won' draws.

4. GENERAL

- (a) If in any game there are 2 or more Division 1 prize winners each prize winner shall, subject to the Big Wednesday Rules 2005, receive an equal share of the Division 1 prize including an equal share of the amount prescribed by NZ Lotteries for a prize in kind.
- (b) If when a prize in kind is claimed, the prize is no longer available for any reason, NZ Lotteries may, at its discretion, substitute the prize in kind for either:
 - (i) a similar prize in kind of equivalent or greater value; or
 - (ii) the monetary amount prescribed by NZ Lotteries for the prize in kind.
- (c) The monetary amount prescribed by NZ Lotteries for a prize in kind may reflect the price NZ Lotteries might otherwise pay for the prize in kind which may be lower than the recommended retail price for the prize in kind.
- (d) All monetary prizes are payable by cheque or direct credit.
- (e) A prize in kind will be delivered only to a prize winner's nominated New Zealand delivery address. Subject to prize availability NZ Lotteries will endeavour to deliver a prize within 3 months (or 5 months if the prize in kind is an Italian motor vehicle) of the prize being claimed.
- (f) The colour, transmission and wheels of a motor vehicle and colour and transmission of a boat received as a prize in kind are at NZ Lotteries discretion.
- (g) These terms and conditions dated September 2011 come into effect on commencement of sales of Big Wednesday on Thursday 8 September 2011.
- (h) NZ Lotteries may at its discretion amend these terms and conditions from time to time and may determine all matters not addressed in these terms and conditions.
- (i) Except for any liability that cannot be excluded at law NZ Lotteries will not be liable to a prize winner in any way in relation to a prize in kind.
- (j) NZ Lotteries may at its discretion determine the type of motor vehicle, boat or charge card offered as a prize in kind and may at any time replace a prize with another prize.
